Introduction & Timeline

Applications are accepted year-round. There is no deadline. Once you've submitted your application, **please allow up to four to five months for review.** You will be notified of your application's status by the decision dates currently posted on [our website](#).

Eligibility Requirements

To be considered eligible to apply for the Community Grant Program, an organization must:

- / Have tax-exempt status under Sections 501(c)(3) or 170(b)(1)(a)(vi) of the Internal Revenue Code and units of government, or have a 501(c)(3) Fiscal Sponsor
- / Work in the following counties: Travis, Burnet, Bastrop, Caldwell, Hays, and Williamson.

The Foundation has limited resources, so there are restrictions on the scope of the activities the Foundation is able to support. In general, the Foundation does **NOT** grant funds for:

- / Unrestricted general operating expenses
- / Endowment funds
- / Religious organizations for religious purposes
- / Fundraising activities or events
- / Umbrella funding organizations that intend to distribute funds at their own discretion
- / Political lobbying or legislative activities
- / Individuals

The Foundation will award grants only to organizations that have met all deadlines for project reporting and accountability for any previous Community Grant award from the Foundation.

The Foundation will only accept one Community Grant request from an organization during a 12-month period.
